**Terms & Conditions:**

**New Enrolment**

- For new enrolment in 2018/2019 into Beaconhouse School the total fees payable will be the Registration Fee + Security Deposit + One Term Fee. One school year comprises of 3 terms. Fees are payable to **BEACONHOUSE MALAYSIA SDN. BHD.**
- Registration Fee is a one-time non- refundable nor transferable payment upon the student being granted admission to the school. Tuition Fees are not transferable. Entrance Assessment is a one-time non-refundable payment upon the child taking the test.
- Parent shall pay additional monies necessary to top up the deposit to maintain it's equivalence to one term's tuition fee on or before the commencement of the relevant accademic term.
- For foreign student's, the visa must be approved by Immigration to be accepted in Beaconhouse.

**School Fees**

- All applicable school fees related to a term are due and payable prior to commencement of the term. School fees must be paid even in the case of absence due to injury, illness or any other cause.
- The School reserves the right to refuse entry to the school to any student whose fees are outstanding for more than thirty (30) days. A penalty of RM50.00 will be levied for late payment of fees.

**Sibling Discounts**

The School recognises the impact the cost of education can have on families with multiple children. In an effort to assist families considering Beaconhouse, the School has established a tuition fee discount for families with multiple siblings. The following applies;

*The 2nd, 3rd, 4th and 5th enrolled child will be given a 5%, 10%, 15% and 20% discount respectively.*

*If there is more than 5 children, the 20% discount is applicable.*

**Definition of sibling:** The student must be one of two or more children ( biological and both parents in common ).

This discount is not available to family members outside the sibling relationship such as stepbrothers/sisters, cousins etc.

*(This discount is applicable for the entire duration of each sibling's study at Beaconhouse Schools)*

**Withdrawals**

- All withdrawals must be submitted ONLINE with at least four (4) months notice given before the student's last day of school.
- In the event four (4) months' notice of withdrawal is served and the last day of the notice encroaches into a new term, the school fees for the term will be pro-rated accordingly.
- The security deposit will be refunded after 30 days from the last day of the notice if all withdrawal conditions are met.
- All withdrawals are subject to an administrative charge of RM150
