Terms & Conditions

New Enrolment

- 1. For new enrolment in 2023 into Beaconhouse School the total fees payable will be the Registration Fee + Security Deposit + One Term Fee.
 - Tuition fee is to be paid at the start of each term, three terms a year. Fees are payable to

BEACONHOUSE MALAYSIA SDN. BHD. All fee is non-transferable.

- 2. Entrance Assessment is a one-time non-refundable payment upon the child taking the test. Registration Fee is a one-time non-refundable payment upon the student being granted admission to the school.
- 3. Parent may need pay additional monies to top-up the deposit to maintain its equivalence to one term's tuition fee on or before the commencement of the relevant academic term.
- 4. Foreign students must have duely approved visa by Immigration to be accepted into Beaconhouse Schools.

Withdrawals

- All withdrawals must be submitted ONLINE with at least four (4) months notice given before the student's last day of school.
- 2. In the event four (4) months' notice of withdrawal is served and the last day of the notice encroaches into a new term, the school fees for the term will be pro-rated accordingly.
- 3. Security deposit will be refunded after 30 days from the last day of the notice if all withdrawal conditions are met.
- 4. All withdrawals are subject to an administrative charge of RM150

*All fees and policies are subject to change without prior notice.

School Fees

- 1. All applicable school fees related to a term are due and payable prior to commencement of the term. School fees must be paid even in the case of absence due to injury, illness or any other cause.
- A penalty of RM50.00 will be levied for late payment of fees.
 The School reserves the right to suspend/refuse entry to any student(s) whose fees remain outstanding for more than thirty (30) days.

3. Sibling Discounts

The School recognises the impact the cost of education can have on families with multiple children. In an effort to assist families considering Beaconhouse, the School has established a tuition fee discount for families with multiple siblings.

The following shall apply:

The 2nd, 3rd, 4th and 5th child will be given a 5%, 10%, 15% and 20% discount respectively. If there is more than 5 children, a 20% discount shall be applicable.

Definition of sibling: The student must be one of two or more children (biological and both parents in common). This discount is not available to family members outside the sibling relationship such as stepbrothers/sisters, cousins etc. Applicable for siblings concurrently studying at any of our Beaconhouse Schools in an academic year. Sibling discount will be withdrawn as soon as there is only one sibling left with Beaconhouse.

- 4. Miscellaneous charges include but are not limited to library, resources, lab and technology fee.
- 5. Intensive English (Based on recommendation from school) After school Programme
- Junior (Year 1 Year 3) RM 200 per month
- Junior (Year 4 Year 6) RM 300 per month
- Senior (Year 7 Year 9) RM 350 per month
